General

The Lawyers' Announcements section is reserved to announce the following:

- New members to a law firm or legal department
- Name change of a law firm
- Formation, merger, or new affiliation of law practice(s) and law-related associations
- Relocation of a law practice
- Change in job status
- Retirement of attorneys
- Notices of professional appointment, honors, or awards

Quarter page vertical

- 3.75" wide x 4.25" tall

Half page horizontal

- 7.75" wide x 4.25" tall
- \$450 CBA members; \$575 nonmembers

- 7.75" wide x 8.875" tall
- \$800 CBA members; \$950 nonmembers
