We joined forces with the Jewish lobby to mandate the teaching of the Holocaust during WWII. Our bill was signed into law within the year by Governor Rick Snyder.

# Greatest inspiration or influence and why:

My dad. He believed that there was nothing I couldn't do if I put my mind to it. He believed that women should be educated so that they could take care of themselves and their families. "Why work for minimum wage if you could earn \$50 an hour?" he would say. That was a lot of money when I was growing up.  $\odot$
