General

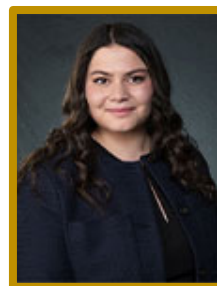

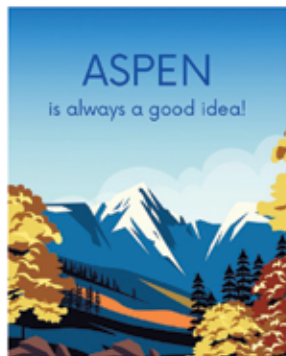
